**COVID-19 SCHOOL YEAR RELEASE & INDEMNIFICATION**

Based upon governmental requirements and guidelines regarding the COVID-19 outbreak, Hill Country Montessori School, Inc. (School) will begin the 2020-2021 School Year (School Year) in person with appropriate precautions on August 19.

We are the parents/guardians of the minor child identified below and we understand and acknowledge all of the following:

1. That School is complying, and will continue to monitor and comply, with all applicable COVID-19 guidelines from the CDC, TEA, and other federal, state, and local governmental agencies;
2. That School is implementing and enforcing the COVID-19 Procedures listed in the attached document immediately and that it will require all employees, parents, children, and visitors to comply with these procedures; and
3. That despite all of its precautions, the School cannot, and does not, guarantee that our child will not be infected with, and made ill by, COVID-19 if our child attends the School Year.

ASSUMPTION OF RISK. We further understand and agree that our child attending the School Year carries with it a risk of our child being infected with, and made ill by, COVID-19. *We voluntarily assume any and all risks of COVID-19 infection, illness, injury, or health consequences (COVID-19 Related Health Consequences) caused by, or arising from, our child attending the School Year.*

RELEASE & INDEMNIFICATION. WE UNDERSTAND, ACKNOWLEDGE, & AGREE THAT AS A PRE-CONDITION TO OUR CHILD ATTENDING THE SCHOOL YEAR, THE SCHOOL IS REQUIRING US TO INDEMNIFY IT AGAINST ANY LOSS, DAMAGES OR COSTS, AND RELEASE IT FROM CERTAIN CLAIMS OR CAUSES OF ACTION THAT WE MIGHT HAVE AGAINST IT FOR ANY COVID-19 RELATED HEALTH CONSEQUENCES ARISING FROM OUR CHILD ATTENDING THE SCHOOL YEAR. WE UNDERSTAND THAT BY SIGNING THIS RELEASE WE ARE VOLUNTARILY GIVING UP LEGAL RIGHTS THAT WE MIGHT HAVE AGAINST THE SCHOOL AS SET FORTH BELOW.
