### Registration Policies:

- **Summer Program Dates:** June 8-26 and July 6-17
- All registrations are processed on a first-come, first-serve basis.
- **Registration deadline for the weekly programs is two weeks PRIOR to the start date. Registration received after the deadline may be assessed a late registration fee of \$25.00.**
- If a program reaches maximum enrollment, a waitlist is started, and you will be contacted by the school should a spot become available.
- If there is not sufficient enrollment one week prior to the program start date, the program may be cancelled and all payments for the cancelled program will be refunded.
- Extended day programs (Before/Aftercare) are NOT AVAILABLE during the HCMS Summer Program.
- Registration Forms are required for EACH child and these forms are due two weeks prior to the start date.

### Payment Policies:

- **Full payment must accompany the registration packet.**
- Cancellations, with full refunds, are accepted for any reason up to 2 weeks prior to the start date. A \$25.00 cancellation fee may be charged for program cancellations received less than two weeks prior to the start date. If a program is cancelled, full refunds will be made. No other refunds will be made.
- We do not prorate for camper absences.
- **All registrations are made with the understanding that all campers/adults abide by the rules and regulations described in the Policies and Procedures section of the HCMS Summer Program Brochure and any addendums. HCMS reserves the right to request withdrawal of any camper/adult whose conduct, attendance, or participation is regarded as undesirable or detrimental to the school community. In the event withdrawal is required, refunds will not be made for any portion of the program.**

## Lunch/Snack

- Lunch: Lunch is not provided at Hill Country Montessori School. All campers staying on campus for the full day must bring lunch from home. Half-day campers are released before lunch.
- Snack: HCMS provides a morning snack for all camps. Please notify the HCMS office of any food allergies or dietary restrictions for your child.
